The City Government of Alaminos, through its Bids And Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder contract:

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

The BAC will issue to prospective bidders Eligibility Forms at BAC Secretariat's Office, 2nd Flr., Alaminos City Hall Bldg., upon their submission of LOI and upon payment of a non-refundable amount of **One Thousand Seven Hundred Ten Pesos (Php 1,710.00)** per set to the City Government of Alaminos Cashier. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.

The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable amount of **Two Thousand Five Hundred Sixty Five Pesos (Php 2,565.00)** to the City Government of Alaminos Cashier.

The City Government of Alaminos assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
