**INVITATION TO BID**

The City Government of Alaminos, through its Bids And Awards Committee (BAC), invites interested exemplary companies with permits issued by the National Telecommunications Commission to apply for eligibility and if found eligible, to bid for the hereunder contract:

Name of Contract : **INSTALLATION OF RADIO TRANSMITTERS AND TRANSCEIVERS FOR WIRELESS DATA NETWORK FOR THE IMPLEMENTATION OF WIRELESS INTERNET-BASE GOVERNANCE SYSTEM (PHASE III)**  
 Location : Alaminos City, Pang.  
 Approved Budget for the Contract : P 11,000,000.00  
 Source of Fund : Development Fund and Special Education Fund  
 Contract Duration : 120 Calendar Days

Prospective bidders should have at least five (5) years direct experience in the design and implementation of a high performance switched and routed (wired and wireless) networks as follows :

1. Switching, routing and bridging technologies
2. Wired and wireless internet connectivity
3. Firewall, proxy and NAT Solutions
4. Remote Access
5. Wireless and RF Spectrum Technologies
6. Voice Over IP (VoIP) Technologies
7. Website Design and Development

Bids received in excess of the ABC shall be automatically rejected at the Bid Opening.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act, and is restricted to organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, as specified in Republic Act 5138 (R.A. 5138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, **ITB**. The bidder/s with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness to the technical and financial requirements of the project. In case two (2) or more bidders tie in the financial proposals, and are eventually found to be equally post-qualified, "drawing of lots" shall be resorted to as the tie-breaking method in accordance with GPPB Circular No. 06-2005. The contract shall then be awarded to the Lone **Lowest Calculated and Responsive Bidder (LCRB)** determined after Post Qualification, or after the drawing of lots in case of tie.

Interested Bidders may obtain further information from the Bids and Awards Committee of Alaminos City, Pangasinan, inspect and/or purchase the Bidding Documents upon payment of a non-refundable fee of **Twenty Seven Thousand Five Hundred Pesos (P 27,500.00)** at the Bids & Awards Committee, City Budget Office, 2ndFlr. City Hall Bldg., Alaminos City, Pangasinan beginning **February 22 – March 13, 2010**.

The Bidding Documents shall be received personally by the prospective bidder or his authorized representative.

Bids and eligibility requirements must be delivered to the above-mentioned address on or before **March 13, 2010 at 10:00 AM**. All Bids must be accompanied by a Bid Security in the form of Cash, Certified Check, Cashier's Check, Manager's Check and in amount not less than the amount provided hereunder:
