15.1	The bid security shall be in the form of a Bid Securing Declaration or any of the following forms and amounts: a. The amount of not less than Forty-Four Thousand Pesos (Php 44,000.00) (2% of ABC), if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; b. The amount of not less than One Hundred Ten Thousand Pesos (Php 110,000.00) (5% of ABC) if bid security is in Surety Bond.																		
21	Additional contract documents relevant to the Project that may be required by existing laws and/or the Procuring Entity, such as construction schedule and S-curve, manpower schedule, construction methods, equipment utilization schedule, construction safety and health program approved by the DOLE, and other acceptable tools of project scheduling.																		
	Bidders shall enclose their original eligibility and technical documents described in ITB Clause 16, in one sealed envelope marked "ORIGINAL – TECHNICAL COMPONENT", and the original of their financial component in another sealed envelope marked "ORIGINAL – FINANCIAL COMPONENT", sealing them all in outer envelope marked "ORIGINAL BID". Each copy of the first and second envelopes shall be similarly sealed duly marking the inner envelopes as 'COPY NO. 1 – TECHNICAL COMPONENT' and "COPY NO. 1 – FINANCIAL COMPONENT" and the outer envelope as "COPY 1". These envelopes containing the original and copy 1 shall then be enclosed in one single envelope.
