Bidders shall enclose their original eligibility and technical documents described in ITB Clause 16, in one sealed envelope marked "ORIGINAL – TECHNICAL COMPONENT", and the original of their financial component in another sealed envelope marked "ORIGINAL – FINANCIAL COMPONENT", sealing them all in outer envelope marked "ORIGINAL BID".

Each copy of the first and second envelopes shall be similarly sealed duly marking the inner envelopes as "COPY NO. 1 – TECHNICAL COMPONENT" and "COPY NO. 1 – FINANCIAL COMPONENT" and the outer envelope as "COPY 1". **These envelopes containing the original and copy 1 shall then be enclosed in one single envelope.**
