The amount of not less than Thirty Thousand Two Hundred Sixty-Nine Pesos and 83/100 (Php 30,269.83) (2% of ABC), if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; b. The amount of not less than Seventy-Five Thousand Six Hundred Seventy-Four Pesos and 56/100 (Php 75,674.56) (5% of ABC) if bid security is in Surety Bond.

Each copy of the first and second envelopes shall be similarly sealed duly marking the inner envelopes as "COPY NO. 1 – TECHNICAL COMPONENT" and "COPY NO. 1 – FINANCIAL COMPONENT" and the outer envelope as "COPY 1". These envelopes containing the original and copy 1 shall then be enclosed in one single envelope.
